Texas Agricultural Commissioner Todd Staples Highlights TAIA Business Meeting

Texas Ag Industries held its 2011 Annual Conference and Business Meeting at the Crowne Plaza Hotel in Addison January 18 - 20. Great attendance and a very diverse group of companies and individuals, made the 2011 Conference one of the best on record. TAIA was very honored to have Todd Staples, Texas Agriculture Commissioner, speak to a packed room at the Business Meeting Breakfast about the future of agriculture in Texas.

The 2011 Conference had a record number of thirty-seven companies that were sponsors for the conference and seventeen companies set up meeting rooms to meet with customers and staff. Both conference sponsors and companies with meeting rooms are listed on pages 5 and 6.

The receptions were very well attended with entertainment provided by singer and guitarist Ken Brothers, Wii competition and a very well supported

Congress Moves Legislation On NPDES Permits

The National Pollutant Discharge Elimination System (NPDES) Permits have caught congressional attention. With the help of our national and state associations and contacts by our members, HB 872 was able to move through the House Agriculture Committee and the Transportation and Infrastructure Committee and passed by the full House of Representatives under the Reduced Regulatory Burdens Act. The bill required a two-thirds majority and it passed by a margin of 292 - 134. It now is filed in the Senate as SB 350 by Senator Pat Roberts from Kansas. We will again need a lot of support from our members to get the bill passed out of the Senate where we hear it will face a tougher fight to pass.

On the EPA side, the 6th Circuit Court has granted them a six month delay to start issuing NPDES permits. This moves the implementation date to October 31, 2011. EPA has published draft regulations in the federal register. The Texas Commission of Environmental Quality has regulations ready to publish, but is waiting to see the final EPA regulation.

President's Comments

I hope everyone that attended the 2011 Annual Conference had an enjoyable experience. I would like to thank all those who attended. I also would like to thank those who sent comments for all the positive remarks we received about the conference and the contacts they were all able to make. I hope you pass these comments on to those who were not able to attend so they get January 17 - 19, 2012 on their calendar for next year's conference. Be sure to check the calendar on the back of the newsletter for the dates of the 2011 Regional Planning Committee Meetings. Everyone is invited to join the committees to help plan the regional meetings for this year. It is so important that we get topics related to specific regions of the state and find the best possible speakers to address the subjects. We are also starting to make plans for the Summer Meeting that will be held August 10 -12 in Fredricksburg. Plug in these dates and help make important decisions on how your association will operate this next year.

The Eighty-Second Texas Legislative session is running at full steam with an extremely heavy load to accomplish. Their number one goal is passing a budget with a twenty-four to twenty-seven billion dollar short fall, depending on whom you talk to, for the next biennium. As the budget hearings continue, we are seeing the agriculture agencies taking extreme budget cuts. The agencies are also saying there will be an increase in fees they are charging for their services to help cover the cost. There are several groundwater bills filed, and all of them have some concerns for agriculture. A map of redistricting should soon appear and that will surely bring a lot of discussion. On the federal scene congress is also trying to pass a budget with major cuts, but between all of that we have been able to move the National Pollutant Discharge Elimination System (NPDES) Permits Bill through the House and on to the Senate. The Courts have also given EPA a six month delay to get its NPDES Regulations in place. The Texas Commission on Environmental Quality has also delayed its regulations.

Looking back to 2010, TAIA was able to accomplish many great things. We had a year in which we broke every record for sponsorships at every event TAIA held. We had great attendance at all our meetings. We were able to reach out and do two Anhydrous Ammonia Trainings to help our members comply. I did receive a call last week from the US Department of Transportation saying they are starting inspections in Texas in April. We finally accomplished a membership goal of 500 that we have worked so hard to meet. Thank you for making 2010 a great year, while helping us strive to make 2011 an even a better year with your help and participation.

PIONEER HI-BRED AND ADVANTA COLLABORATE ON SORGHUM TRAITS AND TECHNOLOGY

DuPont and Advanta have entered into a collaboration and licensing agreement to develop and deliver sorghum with increased productivity and value.

Under the agreement, DuPont will provide proprietary biotechnology traits and enabling technologies to Advanta for the purpose of developing improved biotechnology sorghum products. DuPont business Pioneer Hi-Bred and Advanta will have commercial rights to sorghum products developed under the agreement, once regulatory approvals have been received. Terms of the agreement were not disclosed.

"Improving the productivity and livelihoods of farmers everywhere is critical to meeting the demands of the future population, and biotechnology crops continue to play an important role in increasing farmer productivity," said John Bedbrook, vice president - DuPont Agricultural Biotechnology. "Advanta is the leading sorghum developer, and this partnership will enhance our sorghum product offering by providing more options through biotech traits."

A staple grain for many parts of the world, almost three-quarters of the world sorghum crop is used for human consumption. It is grown across the globe and ranks fifth in global production for cereals. It is planted in many dry regions because of its high-energy and tolerance to drought. Pioneer is a leading seller of sorghum in all of the major areas of the United States where sorghum is grown. With a range of forage, grain and sweet sorghum products in its portfolio, Advanta is the world's leading sorghum seed research and marketing company.

"Sorghum is an important crop for food and feed, and in many parts of the world, its role in energy production is growing," said Alberto Leon, research head - Advanta. "This collaboration will accelerate our ability to provide high yielding, high-value biotechnology sorghum products to our customers."

Pastures Now Get Weed Control in *Dry Fertilizer*

HOUSTON – (March 14, 2011) – Texas cattle raisers now have another way to get the benefits of pasture weed control and fertilization in a single step.

The Texas Department of Agriculture recently registered two Dow AgroSciences pasture herbicides- GrazonNext® and Chaparral™ – for impregnation onto dry fertilizer. The products are labeled for impregnation *only* in the state of Texas.

Herbicide impregnated onto dry fertilizer is a staple in lawn applications. And many ranchers utilize herbicide applications with *liquid* fertilizer on pastures and hay meadows. But until the recent registrations, no current pasture herbicide was labeled for impregnation onto dry fertilizer, says Dr. Vernon Langston, a range and pasture field scientist with Dow AgroSciences.

“For ranchers who prefer to use dry fertilizer, this could save a trip or an extra custom application,” Langston says. “At busy times of year, it could mean the difference between having weed control or not.” To impregnate fertilizer with the herbicide, dealers and applicators spray a concentrated solution of the product on dry fertilizer pellets during the blending process. Dow AgroSciences recommends that retailers dye all herbicide-impregnated fertilizer to alert users to the presence of the herbicide. To get an adequate dose of the herbicide properly distributed, the herbicide has to be applied with at least 200 pounds of dry fertilizer per acre. Spreader trucks or fertilizer buggies apply the herbicide-impregnated fertilizer as they would normally apply dry fertilizer.

From there, rainfall puts the herbicide-fertilizer solution into the soil. Weed control is almost entirely dependent upon the soil activity of the herbicide and root uptake by the weeds. For that reason, weed control from herbicide-impregnated fertilizer usually will be less than that from a liquid foliar application, says Andy Carriger, a Dow AgroSciences range and pasture specialist who did much of the development work. Control also may be slower.

“Where we normally expect 90 percent or better control from a liquid application, we often see about 75 percent control from impregnated fertilizer,” he says. “Sometimes it’s better, but 75 percent should be the expectation.”

Because GrazonNext contains 2,4-D, GrazonNext is a state-limited use product in Texas. At least a private applicator’s license is required to self-apply dry fertilizer impregnated with GrazonNext. Chaparral is not a state-limited use product and no license is required to apply it. While Chaparral applied as a liquid foliar treatment can be used to control Pensacola bahiagrass in bermudagrass, its activity on bahia through dry fertilizer is expected to be negligible. Still, Chaparral is not recommended for use on bahiagrass pasture. For more information on impregnated fertilizer, contact your local Dow AgroSciences representative.

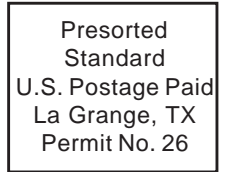
